



## Rose Fest Market at The Ritz | Artisan Application Saturday, April 26, 2025 | 10:00am-4:00pm

Rose Fest Market at The Ritz is a part of the annual Rose Show and Festival and is an outdoor artisan market with food trucks, music, and family friendly activities. It will be held outdoors at The Ritz Amphitheater, which is within walking distance from Thomasville's historic Downtown.

Vendors will be selected based on the needs of the event. Completed application and/or prior year participation does not guarantee event acceptance. Info booth and like entries are not permitted; soliciting is not permitted.

### Artisan Vendor Regulations

**\*Application deadline: February 28<sup>th</sup> - Applications received after this deadline will not be accepted.**

- Rose Fest Market at The Ritz is targeted to the makers who hand craft their own merchandise with a floral, spring like aspect to the product (i.e. floral jewelry pieces, flower paintings, hand crafted planter pots)
- This is not a “buy-sell” show. Items that are manufactured or commercially packaged products will not be permitted (this includes but is not limited to: mass produced ceramics, bedspreads, purses, etc.).
- The artisan booth fee is \$150. **Booth fees are non-refundable.** This includes vendor dropouts, event cancellation due to weather and other unforeseen events.
- Please **do not** mail fees with application. **Selected vendors will be notified after March 10<sup>th</sup>** and will receive instructions on how to make this payment.
- ALL exhibitors must submit photos, even if they have submitted and been accepted in the past. Applications must include:
  - (2) current photos of exhibitor's booth
  - (3) photos of the items requested to be sold during the show
- Each booth space is in a 10' x 10' white tent provided by the City of Thomasville event staff. All booths are outdoors; shady spots cannot be guaranteed.
- All items requested to be sold during the show must be listed on the application.
- Exhibitors must supply their own tables, chairs, and displays as needed. (*Tents will be set up and provided for you.*)
- All tables (both display and supply) are required to be covered with floor length coverings to hide table legs, supplies, boxes, etc.

# ROSE SHOW & FESTIVAL

- The City of Thomasville reserves the right to limit the number of applicants with similar art mediums or products.
- Exhibitors are responsible for collecting and paying Georgia sales tax.
- Parking will not be permitted at booths during the operating hours of the show.
- Event officials reserve the right to change booth location assignments as needed for any reason. Vendors who have set up in an area not assigned to them and without prior approval by on-site staff will be required to move to their assigned space.
- Exhibitors may not break down their booths until 4:00 p.m. Saturday, April 26, 2025. Additional information will go out to chosen vendors.
- Electricity is limited and will be available by request when possible. You will be notified ahead of time regarding the availability of electricity.
- Any exhibitor not abiding by the regulations set forth will forfeit their privilege to participate in current and future shows.
